The North had 11 members, the West had 8 members while the East had 6 members.

After the annexation of Lagos by the British in 1861, a legislative and executive council was constituted for it. In 1862, Lagos and other British territories in the Gold coast, Sierra Leone and Gambia were by a commission dated 19 February 1866, placed under a Governor General based in Sierra Leone.
